RULES OF PARTICIPATION IN CHILDREN'S ACTIVITIES

For the health and comfort of all participants, please do not bring children who are ill, have infections, or are showing symptoms of a cold.

Thank you for your cooperation.

1. Participation Rules

- a) Children's activities are free of charge. After each session, please leave the area clean and tidy.
- b) Activities take place on the premises of Blu Apartments and are intended for children over 4 years of age.
- c) The activities are designed to provide entertainment and organize children's free time; they do not constitute childcare.
- d) Parents or guardians are responsible for supervising their children during all activities.
- e) Outdoor activities depend on weather conditions.
- f) Some activities may include outings outside the premises. Participation in such activities requires signing a consent form. The duration depends on the type of activity and the daily schedule.
- g) Games, workshops, and other activities are conducted by an animator and take place on dates set by Blu Apartments.
- h) The animator reserves the right to refuse participation to a child who does not follow instructions or behaves inappropriately.

2. Responsibility and Safety

- a) Parents/guardians must inform the animator of any illnesses, allergies, or sensitivities their child may have.
- b) The animator is not responsible for children who leave the activity area without permission. Children go to the toilet independently.
- c) Parents/guardians bear full responsibility for their child's safety during the activities and for any damage caused by the child on the premises of Blu Apartments or to third parties.

3. Organization of Activities

- a) Each activity block lasts 60 minutes, unless otherwise stated in the program.
- b) Please bring children to activities on time and pick them up promptly after the session ends.
- c) Activities may be cancelled for reasons beyond the organizer's control.
- d) In exceptional cases, Blu Apartments reserves the right to cancel or modify the program.
- e) During the activities, Blu Apartments reserves the right to adapt the program according to the children's energy, engagement, and well-being.
- f) Children should be dressed appropriately for the type of activity and weather conditions. For physical activities, sportswear and indoor shoes are recommended.

4. Image and Documentation

- a) Recording videos or taking photos by participants or third parties during activities is prohibited.
- b) Publishing a child's image in Blu Apartments' promotional materials requires the written consent of the parent or legal guardian.
- c) The consent form must specify the purpose and form of publication (e.g., social media, website, brochures).

5. Face Painting and Use of Products

- a) Blu Apartments uses only high-quality, non-toxic, and safety-certified products for face painting, suitable for children, including those with allergies.
- b) Nevertheless, caution is advised even certified products may cause unexpected skin reactions.
- c) By granting consent, the parent/guardian releases Blu Apartments and the animator from liability for any reactions resulting from the use of face paints.

6. Acceptance of the Rules

- a) A child's participation in activities implies acceptance of these rules by the parent or guardian.
- b) Blu Apartments reserves the right to amend these rules. The current version is available at the reception desk and on the official website.
