

INFORMATION ON THE PROCESSING OF PERSONAL DATA

Who is the controller of your data?

The controller is Operator Świeradów Zdrój Sp. z o.o., entered in the register of entrepreneurs of the National Court Register under number 0000774092, with its registered office in Warsaw, ul. Widok 8, 00-023 Warsaw.

Separate controllers of personal data will be the companies from the Górskie Resorły group operating the facilities where you may make a stay reservation using this application. A specific company will be the controller of your personal data when you move in the application to the tab of that company's facility. The list of companies that are controllers and their contact details is provided below. Each of them is hereinafter referred to as the "Controller".

For what purpose does the Controller process data in the application?

- *creating and servicing your account in the application,*
- *making a reservation, handling the reservation and stay,*
- *handling any complaints,*
- *issuing the relevant accounting document in connection with the reservation.*

On what basis?

- *necessity for the performance of a contract - reservation, use of the application - until the expiry of the limitation period for claims,*
- *handling complaints and pursuing or defending claims, which constitutes the Controller's legitimate interest - until these interests cease or until an effective objection is raised earlier, but no longer than until the expiry of the limitation period for claims,*
- *performance of legal obligations - tax and accounting obligations - for the period required by law.*

Is providing the data mandatory?

You do not have to provide your personal data to use the application. However, if you want to fully use the application's functionalities, e.g. create an account or make a reservation, providing personal data is required by the Controller. If you do not provide personal data, it will not be possible to use these functionalities.

To whom may personal data be disclosed?

- *software providers - Betasi sp. z o.o.,*
- *entities providing accounting, IT or legal services to the Controller,*
- *payment service providers.*

Your rights

You have the right to:

- *access your data, rectify it, erase it or restrict its processing,*
- *transfer your data to another controller,*
- *object, including objecting to direct marketing,*
- *withdraw consent to processing, if you give it,*
- *lodge a complaint with a supervisory authority.*
