



## **Regulations for a pet's stay at the Linea Mare Hotel**

### **Conditions of admission to the Hotel for a Guest with a Pet**

1. Hotel Linea Mare welcomes guests with pets.
2. Admission to the Pupila Hotel requires notification of the fact of arrival and stay at the time of booking the room. Failure to provide such information may result in a refusal to stay at the Hotel with your Pet or a fine of PLN 1,000.
3. Reporting the arrival of Guests with their Pets to the Hotel allows them to be accommodated in designated rooms. If there are no available rooms for guests with a pet, the hotel may refuse to accommodate and stay them.
4. Stay at the Hotel is only possible for healthy, well-groomed and clean pets. The hotel guest is obliged to have a completed, current health booklet for the Pet, indicating current vaccinations and deworming.
5. The hotel guest (owner) is also obliged to inform about the possible chronic disease of the Pupil when booking the room.
6. The hotel does not accept guests with pets suffering from infectious diseases.
7. The hotel may refuse to accept aggressive and dangerous animals. This also applies to dog breeds commonly considered dangerous or aggressive: Pitbull Terrier, Rottwiler, Doberman, Dog, Sheepdog, Amstaff, Bulldog, Tosa Inu, Moscow Guard.
8. If an animal is found to be aggressive, the Hotel is entitled to ask the Guest to leave the Hotel and his/her Pet immediately.

### **Pet's stay at the hotel**

9. If the hotel employees have justified suspicions that an animal left in the room is disturbing the stay of other guests, the work of the staff, destroying the property of the hotel facility, or may cause a threat to itself, other guests, hotel employees or property, the hotel is entitled to to call the Guest to immediately remove the Pet from the Hotel, and if there is no response to the request, the Hotel may call the appropriate security services to remove the Pet from the facility.
10. All costs resulting from the above circumstances are borne by the owner of the animal in full.

11. If the Pet leaves the hotel room, it should be taken out in a way that ensures the safety of other people and property in the Hotel.

12. Dogs must be walked on a leash and with a muzzle, under the care of the owner or an authorized person. Cats must be walked in carriers/costumes. Walking on a leash, in a muzzle, in baskets or other carriers also applies to other pets.

13. It is not allowed to bring animals into catering and recreation points, the indoor swimming pool and the children's playground.

## **Responsibility for the Pet**

14. If the bedding or other devices and equipment in the room where the animal stays or in another part of the Hotel are soiled (e.g. hair, mud, excrement) or damaged, the owner is obliged to purchase the entire set of bedding or other elements of equipment, and in other cases to cover the costs of repairs.

15. The Pet's owner is obliged to immediately clean up the dirt left by the Pet inside the Hotel and its surroundings.

16. Cat owners must have a litter box with sand and empty it into a plastic bag, which will then be thrown away into marked containers located in the hotel parking lot.

17. Owners are responsible for their animals maintaining silence in the Hotel and not disturbing other guests. In the event of repeated complaints from other guests or staff, the hotel reserves the right to remove the animal from the facility immediately and, if necessary, with the participation of appropriate services.

18. The Pet's owner is responsible for all damage to persons and property of the Hotel or other Guests caused by the animal.

## **Costs of stay**

19. Pet's stay at the hotel is subject to a fee of PLN 95 per day. Additional services are paid according to the price list.
