We respectfully ask that all bookings are to be made online.

A deposit is required within 14 days of making a provisional booking, up to and including 31st October.

A deposit of £15.00pp is required to confirm any party night, festive lunch or festive dinner.

A deposit of £50.00pp is required for New Year's Eve Gala.

Accommodation reservations when attending a function (except New Year's Eve) must be booked via www.marriott.com/stnde – a discount code will be available once you have secured your booking with a deposit.

All deposits and payments are non-refundable and non-transferable and cannot be credited towards drinks or other goods or services.

Payment is to be made in one transaction only and not multiple individual payments.

This responsibility lies with the event booker to ensure this requirement is met.

The full balance must be paid by 31st October 2026 when menu pre-orders are also required for your entire party, with no exceptions.

For bookings made after 31st October 2026, payment is to be made in full at the time of booking, and menu choices are to be completed within your booking reservation.

Failure to meet the required menu pre orders deadlines will result in the Hotel selecting on your behalf and providing a meal of soup, turkey and Christmas pudding which cannot be changed at a later stage.

We regret to inform you that no further dishes can be offered in addition to our standard and free from menus which should cover all dietary requirements. Please make us aware of any allergies within your group prior to booking.
