

NICKEL RESORT & WELLNEST GRZYBOWO

PARKING REGULATIONS

§ 1

1. These Regulations set out the rules for using the unguarded paid car park, hereinafter referred to as the "Parking Area", owned by NICKEL HOSPITALITY SP. Z O.O. – NICKEL RESORT & WELLNEST GRZYBOWO, hereinafter referred to as the "FACILITY".
2. A Parking Area User is a natural person actually using the Parking Area (the person driving the vehicle when entering or leaving the Parking Area, or the owner of the vehicle).
3. A parking space is a designated area within the Parking Area intended for parking a vehicle.

§ 2

1. Entry to the Parking Area (passing through the entrance gate with a barrier) constitutes the conclusion of a paid parking-space rental agreement between the User and the FACILITY under the terms and conditions set out in these Regulations.
2. The parking-space rental agreement expires when the User leaves the Parking Area.
3. By entering the Parking Area with a vehicle, each User accepts the terms of these Regulations and undertakes to comply with their provisions.
4. Users are entitled to park vehicles in designated parking spaces, except for spaces marked by the FACILITY as reserved.
5. Parking in spaces designated for persons with disabilities is prohibited for persons other than users of vehicles holding a valid parking card referred to in Article 8(3) of the Polish Road Traffic Act (Journal of Laws 2005, No. 108, item 908, as amended), displayed in a visible place behind the vehicle windscreen.

§ 3

1. The Parking Area is open 24 hours a day, 7 days a week.
2. The FACILITY has the exclusive right to decide on closing and opening the Parking Area at times determined by the FACILITY and may also temporarily withdraw the Parking Area from use or change its opening hours.

§ 4

Within the Parking Area:

- a) the vehicle traffic rules set out in the Act of 20 June 1997 – Road Traffic Law (Journal of Laws 2005, No. 108, item 908, as amended) apply;
- b) parking vehicles outside designated parking spaces is prohibited;
- c) a speed limit of 10 km/h applies;
- d) vehicles carrying flammable, corrosive, explosive or other similar materials and substances that may pose a risk to persons or property are strictly prohibited from entering, except for vehicles whose driver has been granted permission to park by the Manager;
- e) once parked, the vehicle must be immobilised, the ignition and lights switched off, and the windows, doors and luggage compartment closed. The User is obliged to switch off any radio-frequency devices left in the vehicle;
- f) the Vehicle User is responsible for securing the vehicle against theft.

§ 5

1. Before leaving the Parking Area, the User is obliged to pay the parking fee at the Facility Reception in accordance with the price list publicly available within the Parking Area.
2. These Regulations are publicly available and displayed in a visible place at the entrance to the Parking Area and on the website www.nickelresorts.pl.
3. In the event of loss of the parking ticket, a parking fee in the amount specified in the price list must be paid.

§ 6

The Vehicle User is liable for any damage caused to the Facility and third parties within the Parking Area.

§ 7

1. The Manager shall not be liable for any damage resulting from force majeure, theft, destruction or damage to vehicles located within the Parking Area, or to items left in or forming part of their equipment.
2. The Facility shall not be liable for traffic-related damage involving vehicles or persons using the Parking Area caused by Users or third parties.

§ 8

1. If the User breaches these Regulations, the Facility may terminate the parking-space rental agreement without notice and take measures necessary to restore compliance with the Regulations, including removal of the vehicle from the Parking Area.
2. In the cases referred to in paragraph 1, the User is obliged to cover all costs connected with removing the vehicle from the Parking Area and securing and storing it until collection by the User.
3. The Facility is additionally authorised to remove a vehicle from the Parking Area where there is a sudden and justified threat.
4. In the event of non-payment, the Facility may take all measures aimed at documenting the conclusion of the parking-space rental agreement and pursuing the amount due in accordance with generally applicable law.

§ 9

1. Compliance with the terms of the parking-space rental agreement is monitored throughout the Parking Area by persons authorised by the Facility.
2. Users are obliged to comply with instructions issued by the persons referred to in paragraph 1.

§ 10

1. All complaints and requests relating to use of the Parking Area should be submitted to the Reception of Nickel Resort & WellNest.
2. Nickel Resort & WellNest sincerely hopes that compliance with these Regulations will ensure a peaceful and safe stay for our Guests.
