PET STAY REGULATIONS

§ 1 ANIMALS ON THE FACILITY PREMISES

1. Only dogs are permitted on the Facility premises, subject to the rules specified by the Facility in these Regulations. Other animals may not stay on the premises due to the safety of Guests and the Resort's resources.
2. The Facility reserves the right to refuse admission to a dog of a breed commonly considered dangerous or aggressive and to dogs weighing more than 25 kg.
3. Dogs may stay at the Facility only after individual contact with the Facility and agreement on the conditions of the dog's stay.
4. Guests arriving with a dog may only be accommodated in designated rooms in a separate part of the Hotel. If the Guest fails to notify the Facility in advance of the dog's stay and there are no available designated rooms, the dog will not be permitted to stay at the Facility.

§ 2 RESERVATION OF A GUEST'S STAY WITH A PET

1. A dog may be admitted to the Facility provided that the Guest reports the dog during the reservation process, provides its breed, and the Facility confirms the reservation.
2. The Facility only accepts healthy dogs possessing a health booklet confirming current vaccinations and deworming. The pet owner is obliged to have the pet's current health booklet throughout the stay and present it at the request of staff.
3. Upon arrival at the Facility, the dog owner declares that the animal is healthy and does not pose a threat to other persons or dogs staying at the Resort and accepts these Regulations by signing a declaration attached to the Regulations.

§ 3 RULES FOR A DOG'S STAY ON THE FACILITY PREMISES

1. Dogs whose stay was reported during the reservation may be brought onto the Facility premises by their owners and may stay only in rooms occupied by their owners.
2. While in the outdoor areas of the Facility, the Owner is obliged to keep the dog on a leash and in a muzzle.
3. Dogs are strictly prohibited from entering the restaurant, children's playroom, gym, SPA area and recreational areas.
4. The dog owner is obliged to clean up any waste left by the animal, both in the room and in common areas within the building and around the Facility. This cleaning obligation does not apply to a guide dog assisting a blind person and/or a person using a wheelchair.
5. Hotel bedding, towels and dishes must not be used for the dog's needs. The dog may not stay on beds, sofas or armchairs forming part of the Facility's furnishings, and the dog owner should provide the animal with its own bed/kennel.
6. The owner is obliged to have a vaccination record for the dog. The dog owner must ensure access to fresh water and food.
7. If the dog is left alone in the room, a "pet in room" sign must be placed on the outside door handle.
8. The Owner is responsible for ensuring that the dog remains quiet in the room and does not disturb other Guests of the Facility. The dog should not be left alone in the room if it disturbs the peace of other Guests and this lasts longer than 20 minutes.
9. In the event of repeated complaints from hotel Guests or staff, the Facility reserves the right to demand that the dog be removed from the Resort premises. In extreme situations, where contact with the Owner is not possible, the Facility reserves the right for staff to enter the room, if necessary with the assistance of the relevant services, and transport the dog to the nearest animal shelter. All costs arising from the above actions shall be borne by the pet owner.
10. For safety reasons, a room occupied by a dog is cleaned only in the presence of the Owner or when the dog is absent from the room. Please contact the Facility staff to arrange a suitable time.

§ 4 FEES FOR A DOG'S STAY AT THE RESORT

1. The stay of each dog on the Facility premises is subject to a fee.
2. The fee for one dog staying on the Facility premises is PLN 50 per day.
3. If the Facility is not informed of the dog's presence on the premises: a) the dog stay fee will be charged at 150% of the fee specified in point 2; b) the hotel Guest will be obliged to change rooms and occupy a room designated for stays with dogs; c) the Resort Guest will be charged a flat fee of PLN 500 for sanitisation of a room not designated for stays with dogs.
4. In the event of soiling (fur, mud, urine, faeces) or damage caused by the dog to the mattress, floor covering or other room furnishings in which the dog stayed, or to parts of the Facility's equipment and its surroundings, including vegetation on the Facility premises, the owner is obliged to cover the costs of repair or replacement with

new items based on the Facility's valuation.

5. A flat fee of PLN 400 is established for replacement of a set of hotel bedding soiled/damaged by the dog.

6. The dog owner bears full financial responsibility for all damage caused by the dog, both to the Facility's property and to other Resort Guests.

7. If a dangerous situation arises as a result of the dog's stay on the Facility premises, the dog owner shall cover all costs of calling the relevant services to the Facility and any costs of the dog's stay in an animal shelter.

§ 5 FINAL PROVISIONS

1. The dog owner is obliged to comply with the Facility Regulations concerning quiet hours and not disturbing the peace of other Resort Guests or other dogs staying on the premises.

2. In the event of repeated complaints from other hotel Guests concerning the dog's stay at the Hotel and failure to comply with these Regulations, the Facility reserves the right to immediately terminate the Guest's stay with the dog without refunding the fee paid for the stay.

3. The Owner declares that they have read these Regulations.
