

## REGULATIONS FOR GUESTS STAYING IN OSADA ŚNIEŻKA TOGETHER WITH THEIR DOG

1. Osada Śnieżka accepts the stay of Guests with a dog for an additional fee (50 PLN / day) in the apartments specified by Osada Śnieżka.
2. The owner of the dog is obliged to carry a dog's health book with current vaccinations, including mandatory rabies, a muzzle and a leash.
3. Osada Śnieżka may refuse to accept animals of the species commonly regarded as dangerous or aggressive, in particular:
  - American Pit Bull Terrier,
  - Majorca dog - Perro de Presa Mallorquin,
  - American Bulldog,
  - Argentine Dog,
  - Canary Dog - Perro de Presa Canario,
  - Tosa Inu,
  - Rottweiler,
  - Akbash Dog,
  - Anatolian Karabash,
  - Moscow Guard Dog,
  - Caucasian Shepherd.
4. It is forbidden to bring dogs to the area:
  - SPA,
  - indoor and outdoor swimming pools with adjoining terrace,
  - Playrooms Kids Club and Gym,
  - outdoor playgrounds,
  - sports fields,
  - restaurant halls.
5. The owner of a dog is obliged to provide:
  - leash,
  - muzzle,
  - dog bowls,
  - a towel for wiping paws and dog bed.
6. The dog in Osada Śnieżka must be under the full control of the owner and be led by on a leash.
7. The dog cannot interfere with the rest of the people staying in Osada Śnieżka.

8. Apartments where dogs are staying will be cleaned only when the dog is not in the apartment or if it will be under the care of the owner.
9. The owner of the dog is obliged to immediately clean up the dirt left by his dog. If you do not have your own bags, they are located in special distributors in the apartment part of Osada Sniezka or at the hotel reception.
10. The owner of the dog bears full financial responsibility for any kind of damage, dirt or damage in the equipment and technical facilities of the hotel made by the dog.
11. The owner of the dog releases Osada Sniezka and its employees from all liability for all damage caused by the dog to third parties and the property of these people.
12. The amount of the fee for damage caused by the dog will be assessed by the responsible persons from Osada Sniezka.
13. The owner of the dog is obliged to comply with all comments of the staff and management of the Facility, specifying the rules of the dog's stay in Osada Sniezka.
14. For non-compliance with the above-mentioned regulations, Osada Sniezka reserves the right to impose a financial penalty, including refusing further stay to the guests, and the owner at the same time undertakes to leave the area of Osada Sniezka together with the dog.
15. In the case of repeated complaints from other guests of Osada Sniezka on behavior, Osada Sniezka reserves the right to refuse to continue providing services (in particular to stay) to the owner of such a dog.
