

REGULATIONS FOR GUESTS STAYING IN OSADA ŚNIEŻKA TOGETHER WITH ANIMALS

1. Osada Śnieżka permits guests to stay with pets for an additional fee of PLN 50 per day in apartments designated by Osada Śnieżka.
 2. Pet owners are required to carry the pet's health booklet with current vaccinations, including mandatory vaccinations.
 3. Osada Śnieżka reserves the right to refuse admission to animals of breeds or species commonly recognized as dangerous, aggressive, or posing a threat to the health, life, or safety of guests, staff, or hotel property, including but not limited to:
 - a) Dogs of breeds commonly recognized as dangerous or aggressive, including but not limited to: American Pit Bull Terrier, Perro de Presa Mallorquin (Majorcan Mastiff), American Bulldog, Dogo Argentino, Perro de Presa Canario (Canary Mastiff), Tosa Inu, Rottweiler, Akbash Dog, Anatolian Karabash, Moscow Watchdog, Caucasian Shepherd, as well as any mixes of these breeds;
 - b) Predatory, wild, and hybrid cats (including crosses of domestic cats with wild species);
 - c) Other wild or exotic mammals, particularly monkeys, skunks, raccoons, non-domestic ferrets, and other species requiring special permits or posing risks;
 - d) Birds of prey, wild birds, and large or loud exotic birds;
 - e) Venomous, aggressive, or otherwise hazardous reptiles, amphibians, and other exotic animals requiring specialized care.
- Osada Śnieżka reserves the right to individually assess each case and to refuse admission of any animal, regardless of species, breed, or size, if its presence could constitute a danger or cause inconvenience to other guests.
4. Animals are prohibited in the following areas (except for guide and assistance dogs, upon prior presentation of certification):
 - a) Spa;
 - b) Restaurant;
 - c) Outdoor pool and adjoining terrace;
 - d) Kids Club playroom and Gym;
 - e) Outdoor playgrounds;
 - f) Sports fields;
 - g) Indoor pool.

5. Pet owners are required to provide:
 - a) Leash, muzzle, or carrier;
 - b) Food bowl;
 - c) Bedding or cage.
6. Pets on the premises of Osada Śnieżka must remain under the full control of their owner and must be kept on a leash or in a carrier.
7. Pets must not disturb the rest or comfort of other guests at Osada Śnieżka.
8. Apartments housing pets will be cleaned only during the absence of the pet or in the presence of the owner, who must maintain full control of the animal.
9. Pet owners must immediately clean up any waste left by their animals. If owners do not have their own waste bags, they are available from designated dispensers in the apartment area or at the hotel reception.
10. Pet owners are fully financially responsible for any damage, soiling, or destruction caused by their animals to hotel equipment or technical installations, and the cost of repairs/restoration may be added to the final bill.
11. Upon checking out of the apartment, if any damage or soiling caused by the pet is identified, the owner will be charged for the repair or restoration of the apartment to its original condition.
12. Pet owners release Osada Śnieżka and its staff from any liability for damages caused by their pets, whether intentional or unintentional, to third parties or their property.
13. The cost of any damage caused by a pet will be assessed by authorized personnel of Osada Śnieżka.
14. Pet owners are required to comply with any instructions from hotel staff or management regarding the rules of their pet's stay at Osada Śnieżka.
15. Failure to comply with this policy may result in financial penalties, including refusal of further stay, and the owner will be obliged to vacate the premises along with their pet.
16. In the event of repeated complaints from other guests regarding a pet's behavior, Osada Śnieżka reserves the right to refuse further services (including accommodation) to the owner of that pet.
